

## Bobbin Mill Cottage, Crosthwaite, Cumbria – Booking Request

When you make this booking you are entering an agreement with us. Please read our terms and conditions below:  
The price of the accommodation includes membership of a local health club and the bed linen. Electricity is by coin meter (£1.00 coins). Occupancy is limited to the number of people stated below.

**Pets:** Well behaved dogs are permitted BY PRIOR ARRANGEMENT and subject to the extra charge of £15.00 per pet. Your dog is not allowed in any of the bedrooms or on the furniture, neither can it be left alone in the property. You must provide your own suitable dog bed. Dogs may be exercised in the gardens, but mess must be cleared up immediately.

**Cancellation and Insurance:** Once you have booked your holiday, our agreement is a legal contract and your deposit is NON REFUNDABLE. The balance of the rental is due 6 weeks prior to the holiday commencing. Failure to make this payment in time will be treated as a cancellation. Holidays booked less than 6 weeks before commencement must be paid in full at the time of the booking. If for whatever reason you cannot take your holiday and the booking cannot be re-let, you are still liable to pay for the booking in full, even we have not yet received your balance. For this reason we strongly recommend that you take out cancellation insurance, which is inexpensive and can be obtained from any good broker. If we do succeed in re-letting the booking, you are no longer liable for the balance, or we will refund it to you if you have already paid it, less a £20 administration fee.

**Non-availability of accommodation:** We would only cancel your holiday if your accommodation was unavailable for reasons beyond our control. We would attempt to offer you alternative accommodation, however if this was not possible, or unacceptable to you, then we would refund all monies paid by you for the holiday. Our liability would not extend beyond this refund.

**Extent of liability:** No liability is accepted to any person for personal injury, sickness, loss or damage to property however sustained or caused, nor for the loss or theft of property and/or money.

We reserve the right of access to the property at any reasonable time during the holiday for inspection or maintenance purposes. A word of caution to those with children - Bobbin Mill Cottage is located alongside a river and youngsters must be supervised at all times when playing in the extensive grounds. The property will be available from 3.00pm on the day of arrival and must be vacated by 10.00am on the day of departure. Directions to the property and access information will be forwarded when the balance of payment for the booking has been received.
